



## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made and executed on 26 th November, 2022 between CT University, Ludhiana (INDIA) and Shahrood University of Technology, Shahrood (IRAN).

CT University having its campus at Ferozepur Road, Ludhiana, Punjab (India)

(hereinafter referred to as "CTU" and includes its associates, constituents, affiliates, units, etc

whatever called) as THE FIRST PARTY.

### AND

Shahrood University of Technology herein referred to as THE SECOND PARTY.

CT University, Ludhiana and Shahrood University of Technology, Shahrood wishing to establish professional collaboration between the two institutions, agree to cooperate with each other as follows...

## PARTY-I: CT UNIVERSITY, LUDIJIANA, INDIA

CT University strives to provide a technologically advanced, ultra -modern academically and socially vibrant campus that offers a safe and supportive educational environment for all. The CTU has housed different constituent Schools, namely School of Design & Innovation, School of Humanities and Physical Education; School of Hotel Management, Airlines & Tourism; School of Law; School of Engineering & Technology; School of Pharmaceutical & Healthcare Sciences; School of Management Studies and School of Agriculture & Natural Sciences. The curricular and research programs are re-prioritized to make these need-based to bridge the gap between industry and academia.

## PARTY -II: Shahrood University of Technology

Shahrood University of Technology is composed of 14 faculties, one E-learning center and four campuses (Pardis) including: 1) Central, 2) Engineering and New Technology, 3) Agricultural Engineering, and 4) Educational Mine.

Shahrood University of Technology strives to provide a technologically advanced, ultra – modern academically and socially vibrant campus that offers a safe and supportive educational environment for all. The Shahrood University of Technology has different faculties including Computer Engineering, Electrical Engineering, Mechanical Engineering, Civil & Architectural Engineering, Architectural Engineering and Urbanism, Mining, Petroleum & Geophysics Engineering, Industrial Engineering & Management, Agricultural Engineering, Chemical and Materials Engineering, Chemistry, Physics, Mathematical Sciences, Geosciences and Physical Education

#### AREAS OF COOPERATION

Subject to mutual consent, the areas of cooperation will include any mutually identified programme offered at either institution as thought desirable and feasible on either side and that both sides will contribute to the fostering and development of the cooperative relationship between the two universities. Cooperation shall be carried out through such mutually identified activities as:

- · Exchange of faculty and/or staff
- Exchange of students
- Joint research activities and publications
- Joint organizations of conferences / academic meets / professional interfaces, etc.
- Participation in seminars and academic meetings
- Exchange of academic resource materials and other information
- Short-term academic and research programs as to be identified

## GOALS AND OBJECTIVES OF MOU

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions.

- a) To exchange information on research and educational programmes
- b) To exchange information on teaching, learning material and literature relevant to their educational and research programmes
- c) To jointly organize short-term continuing education programmes on topics of mutual interest and to invite each other's faculty and students to participate therein
- d) To jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty and students to participate therein
- e) To jointly propose and engage in sponsored research or training programmes and to invite each other's faculty and students to participate therein
- f) To exchange, on a reciprocal basis, students at Undergraduate, Post Graduate and Doctoral levels for limited periods of time for purpose of education and /or research.

# TERMS OF IMPLEMENTATION, RENEWAL, REVISION, CANCELLATION AND NOTICES

- This MoU becomes effective on the day it is signed and remains valid for five years at first instance.
- Details of the implementation of any particular exchange resulting from this MoU shall be negotiated between the two universities.
- This MoU may be renewed after five years with the consent in writing of both the universities.
- Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not be binding unless agreed to writing and signed by both the universities.
- Each university may cancel the MoU by notifying the other University of its Intent to
  do so at least six months in advance of its expiration.
- · Projects in progress at the time of termination will remain unaffected.
- The report of progress of the signed MoU will be produced within the each financial year of the operational period of MoU, and signed by both the parties.

- The publication in print and in electronic format, based on the joint efforts will be the
  joint intellectual property of both universities.
- Any dispute that may arise between the parties regarding to the interpretation or application of this agreement shall be amicably resolved by direct consultation or mutual negotiation.
- CT University and Shahrood University of Technology do hereby agree that they will advertise or use the name and/or logo of any partner university for marketing & promotional material.
